Disc Golf Only	\$5/person

OVERNIGHT USE (UP TO 24 HOURS)

*Grounds Fee	\$75
Quaker Knoll House	Additional \$100
Clark Lodge	Additional \$125
Cabins (10 available)	Additional \$20/each

*All rentals (except "Disc Golf only") require the Grounds Fee. Grounds include use of playground, benches and picnic table, bath house (toilets and shower), small gazebo, amphitheater, two fire pits, baseball diamond, walking trails, and 18-hole disc golf course, plus space for tents and campers (no utilities).



ADDITIONAL INFORMATION:

- Bath houses are not handicap accessible.
- Handicap accessible bathrooms are available with a reservation of the Quaker Knoll House.
- Maximum overnight occupancy of Quaker Knoll House is 14 persons.
- Quaker Knoll House has a full kitchen and two main-floor bathrooms, plus a full finished basement with an additional bathroom.
- Overnight guests are responsible for bringing their own towels, linens, pillows, and bedding.
- Clark Lodge is not intended for overnight occupancy.
- Clark Lodge is only available April thru October.
- Clark Lodge rental includes use of its kitchen.
- Maximum overnight occupancy of each cabin is 8 persons (4 sets of bunk beds in each cabin); 10 rustic cabins are available April thru October.
- No more than 10 tents/pop-up trailers will be permitted on the grounds overnight.
- No more than 4 campers/RVs will be permitted on the grounds overnight. Campers are to be parked on gravel area next to Clark Lodge.
- All buildings are smoke free.
- Alcoholic beverages are not permitted on the grounds or in any of the buildings.
- Pets are not permitted on the grounds or in any of the buildings.
- A \$50 deposit is required at time of booking to hold your reservation. The deposit will be credited to your final payment.
- Damage beyond ordinary wear and tear will be billed to the person /organization renting the facility.
- Members of Wilmington Yearly Meeting are exempt from fees, but donations are encouraged to help cover the cost of gas, electricity, trash, and grounds maintenance.
